BYLAWS REVIEW

Continued from March Membership Meeting

explanation: This article is for the official address of BTRPC. It is recommended to use the actual address of BTRPC and not any officer or individual of the club. The existing verbiage is lined through and the highlighted is the recommendation.

ARTICLE ONE

SECTION 1: The registered office shall be located at ~~71 Boulder Creek Dr., Otis, Oregon 97368~~ 158 Wade Road, Siletz, Oregon 97381

explanation: Currently we do not have a method for removing a member for any obvious disregard for the rules. The addition of Section 10 would provide a remedy to this situation.

ARTICLE TWO

MEMBERS

SECTION 10: Any member may resign by filing a written resignation with any of the board members. Resignation shall not relieve a member of unpaid dues or other charges previously accrued.

Any member who has been determined to be in flagrant disregard of the rules of Big Timber Rifle and Pistol Club can have their membership terminated by a majority vote of the members present at a membership meeting. The process for termination shall be as follows: The offense shall be presented to the membership for discussion followed by a motion for a vote. The members shall then be provided a paper ballot to completed and presented to the Secretary for the official count. Should there be a tie in the vote then a second session of discussion will take place followed by a verbal vote. The paper ballots will be maintained in a separate envelope with the name of the **individual** and a description of the offense. These records will be kept for a minimum of 10 years.

explanation: The following two items need to be reviewed. They are conflicting statements and one needs to be accepted and the other removed from the By-Laws. The conflicting statements are highlighted.

ARTICLE THREE

DIRECTORS

SECTION 2: Whenever any vacancy shall occur in the Board of Directors by death, resignation,

disqualification, or from any other cause, the vacancy shall be filled at the next following monthly meeting. Each voting member shall cast one ballot voting for one nominee. The director elected shall be the nominee garnering the most votes of those voting members present. The director elected to fill the vacancy shall hold office for the unexpired term of the director whom he succeeds, and until his successor shall have been elected and shall have been qualified. Vacancies may be filled on an interim basis by the Board of Directors.

ARTICLE FIVE

OFFICERS

SECTION 4: The officers of the corporation shall hold office until their successors are chosen and qualify in their stead. Any officer or agent elected or appointed by the Board of Directors may be removed by the Board of Directors whenever, in its judgment, the best interests of the corporation will be served thereby, but such removal shall be without prejudice to the contract rights, if any, of the person so removed. If the office of any of the officers becomes vacant for any reason, the vacancy shall be filled by the Board of Directors.
