GENERAL MEMBERSHIP RULES

- 1. It is the responsibility of each member, participant and guest to follow all Big Tiber Rifle and Pistol Club (BTRPC) General Membership Rules as well as Standard and Specific Range Rules.
- 2. All members must participate in a range orientation prior to being issued a gate key and using the ranges or facilities of the club.
- 3. Members are responsible for the actions of their guests. Members will ensure their guests know and understand all BTRPC General Membership Rules as well as Range Rules and Emergency Procedures prior to the guests using the ranges or facilities of the club, and their guests abide by all such rules while on club property.
- **4.** Rule violations by guests may result in enforcement actions against both the guest and the hosting member.
- 5. Anyone observing a violation of any rule must immediately bring it to the attention of a Range Safety Officer (if present) and/or the person committing the violation so corrective action may be taken and further violations may be avoided.
- 6. The hunting or killing of any animals or birds on club property is strictly forbidden at all times, whether domestic or wild, in season or out. Violations are criminal acts.
- 7. Club property shall not be destroyed, moved between ranges or removed from the ranges by any person without specific permission from the Board of Directors. Violations are criminal acts.
- 8. BTRPC ranges and facilities are unstaffed outside of formal events and scheduled training. Members present and using the ranges and facilities during unstaffed activities are expected to act as Range Safety Officers (RSO) for themselves and their guests, coordinating with others as required.
- **9.** Commands of a RSO must be obeyed by all persons on that range, whether participating in activities or just observing.
- **10.** No alcoholic beverages or controlled substances are permitted on BTRPC property, including empty containers. In addition, no shooter scheduled to fire will be allowed to fire if it can be determined the shooter has been

drinking an alcoholic beverage or is under the influence of a controlled substance before he/she is scheduled to shoot.

- **11.** A shooter who does not appear to be able to safely handle firearms for reasons of illness, or consumption of legal or illegal drugs, or for any unknown reason, will be removed from the range without firing. The RSO will make that decision. The decision of the RSO is final.
- **12.** All Certified Firearms Instructors who wish to conduct training of any sort on club property must first register with the BTRP Board of Directors before commencing training.
- **13.** Pets on club property must be on a leash or remain in vehicles.
- 14. Smoking is not allowed in the classroom or within 10 feet of the entrance to the classroom. Smoking is limited to outside graveled areas. Smokers are to clean up after themselves, properly picking up and depositing used smoking materials in a trash can.
- **15**. Anyone observing repeated rule violations after the violator has been made aware of their violation, or severe violations resulting in theft or destruction of property or poaching, are asked to report violations to the Board of Directors and/or the Lincoln County Sheriff's Office or the Oregon State Police as deemed appropriate for the violation.
- **16**. Any violation of a General Membership Rule or Range Rule may result in a penalty up to and including the permanent revocation of your membership without reimbursement.
- 17. Weapons that are capable of being fired 'full-auto' or weapons containing other 'select fire' based trigger systems (such as 2-round or 3-round burst trigger options) are prohibited from being used on the range

EMERGENCY PROCEDURES:

BTRPC has no provisions for emergency medical care on its ranges or property. It is the responsibility of each BTRPC member or event organizer to provide emergency medical equipment and support as necessary. Nonclub events, i.e. Law Enforcement, defensive firearm training, group events, must provide a

-

minimum of an emergency first aid kit, gunshot trauma kit and a qualified first aid provider to conduct events at BTRPC.

- Emergency medical support is available from Siletz Volunteer Fire Department or Lincoln County Emergency Responders
- Cell phone communications is very weak on BTRPC property.
- In the event of an emergency or incident on the range/BTRPC property contact the Club President or the Range Manager as soon as possible.

50 YARD RANGE RULES

- Shooting hours begin at 9:00am and end at sunset or 8:00pm, whichever is earlier, all year long, regardless of daylight hours. After daylight shooting on the range requires specific permission from the Board of Directors for a designated date and time, and for each occurrance.
- 2. Formal events of Big Timber Rifle and Pistol Club and scheduled training by law enforcement or authorized instructors will include the designation of an official Range Safety Officer and a Match/Training Director, one person may at times be designated for both roles.
- 3. Informal shooting shall not interfere with formal events and scheduled training but may be permitted at the discretion of the Match/Training Director of the event or training.
- 4. Firearms shall be discharged only in a safe direction, so the projectile's impact occurs in a pre-designated location specificially designed to safely dissipate all of the projectile's energy.
- 5. Only firearms in safe working order which have been properly maintained shall be discharged.
- 6. When not in a shooting station, all firearms shall be carried in a case or unloaded with the cylinder/breech open and in a safe manner. This rule extends to range parking lots.
- 7. No firearm shall be loaded until the shooter is at the shooting station. Loading is considered as putting ammunition into any part of the firearm. Magazines may be loaded before

approaching the firing line, but magazines may not be placed into the firearm until the shooter is at the shooting station. There will be no loaded firearms behind the yellow safety line.

8. Cease Fire Command, Cold Range and Hot Range Designations:

a. Anyone may call a 'Cease Fire' at any time, for any reason.

b. When a 'Cease Fire' is called, the range is immediately designated a 'Cold Range' and all firearm actions must be opened, emptied of all ammunition, and moved safely to the rack.

c. No person may go forward of a firing line except during a designated 'Cold Range.'

d. During a 'Cold Range,' all firearms are to remain safely racked and there is to be absolutely no touching or handling of any firearms.

e. During a 'Cold Range' there is to be no handling of firearms for the purposes of unpacking upon arrival or packing to leave.

f. All firearms must remain unloaded, racked or packed and untouched, while any person is down range and until the 'Hot Range' designtion is called.

g. Only after the 'Hot Range' designation is called, may firearms be once again moved to the firing line for loading/firing and/or packed and unpacked for transportation.

- **9**. A firearm shall not be handled with the muzzle pointed in the direction of any person.
- **10.** Approved eye and hearing protection is required for every person on all firearm ranges.
- **11.** No tracer rounds of any kind are to be used on the range.
- **12.** No exploding targets, exploding bullets, or incendiary devices are to be used at any time.
- 13. No glass, plastics, metals or woods not specifically and commercially designed as targets shall be used as targets on any range (vegetables, fruit, furniture, electronics, cans of any type are <u>not</u> range authorized targets). Paper, cardboard or clay targets and backers, along with proper stands shall be used at all

times No throwing devices are allowed on this range.

- 14. After using a range you and your party are responsible for the immediate cleanup of that range. Remove used targets, pickup empty cartridge brass and live ammunition, sweep if necessary; unwanted live ammunition can be deposited in the red "dud" can. <u>DO NOT</u> <u>THROW LIVE AMMUNITION INTO ANY</u> <u>GARBAGE CAN OR GARBAGE PILE</u>.
- **15.** There will be no loaded firearms behind the yellow safety line.
- **16.** No steel targets unless at a BTRPC organized or approved event.
- 17. Pistols, carbines and rifles may be used on the 50 yard range. Intermediate rifle calibers are allowed, i.e. 556, AK 47 etc. NO LARGE CALIBERS (HUNTING) CAN BE USED ON THIS RANGE. Shotguns may be used when firing at ground targets. No aerial targets of any kind.
- **18.** Do not shoot the range markers, supporting posts, telephone poles, or no blue sky barrier in front of the bench.
- Weapons that are capable of being fired 'full-auto' or weapons containing other 'select fire' based trigger systems (such as 2-round or 3-round burst trigger options) are prohibited from being used on the range.

ARCHERY RANGE RULES

- **1.** Archery only. No firearms are allowed on the archery range.
- 2. No shooting of live animals are allowed on any range or any part of the Big Timber property.
- **3.** Shooters in both lanes must shoot from the same yardage line. No one may be closer to the target than a shooter in the opposite lane.
- 4. No alcohol is allowed on the archery range or any other part of the Big Timber property.
- 5. Only field points are allowed on the targets.
- 6. All shooters must rack their bows before anyone may go to retrieve their arrows.
- 7. Any shooter or observer may call a cease fire if any unsafe condition occurs. The cease fire will remain in effect until all parties agree the condition no longer exists.

PISTOL RANGE RULES

- 1. Shooting hours begin at 9:00am and end at sunset or 8:00pm, whichever is earlier, all year long, regardless of daylight hours. After daylight shooting on the range requires specific permission from the Board of Directors for a designated date and time, and for each occurrance.
- 2. Formal events of Big Timber Rifle and Pistol Club and scheduled training by law enforcement or authorized instructors will include the designation of an official Range Safety Officer and a Match/Training Director, one person may at times be designated for both roles.
- 3. Informal shooting shall not interfere with formal events and scheduled training but may be permitted at the discretion of the Match/Training Director of the event or training.
- 4. Firearms shall be discharged only in a safe direction, so the projectile's impact occurs in a pre-designated location specifically designed to safely dissipate all of the projectile's energy.
- 5. Only firearms in safe working order which have been properly maintained shall be discharged.
- 6. When not in a shooting station, all firearms shall be carried in a case or unloaded with the cylinder/breech open and in a safe manner. This rule extends to range parking lots.
- 7. No firearm shall be loaded until the shooter is at the shooting station. Loading is considered as putting ammunition into any part of the firearm. Magazines may be loaded before approaching the firing line, but magazines may not be placed into the firearm until the shooter is at the shooting station.
- 8. Cease Fire Command, Cold Range and Hot Range Designations:

a. Anyone may call a **'Cease Fire'** at any time, for any reason.

b. When a '**Cease Fire**' is called, the range is immediately designated a '**Cold Range**' and all pistol action must be open, magazines removed, emptied of all ammunition, and left on the firing bench. 22lr rifles, or less, shall have actions open, magazines emptied and placed on

the rack at the back of the shooting station. All persons shall stand behind the yellow line until the range is declared hot again.

c. No person may go forward of a firing line except during a designated '**Cold Range**.'

d. During a '**Cold Range**,' all firearms are to remain safely racked and there is to be absolutely no touching or handling of any firearms.

e. During a 'Cold Range' there is to be no handling of firearms for the purposes of unpacking upon arrival or packing to leave. During a cold range you may load detached magazines behind the yellow line.

f. All firearms must remain unloaded, racked or packed and untouched, while any person is down range and until the **'Hot Range'** designtion is called.

g. Only after the **'Hot Range'** designation is called, may firearms be once again moved to the firing bench for loading/firing and/or packed and unpacked for transportation.

- **9.** A firearm shall not be handled with the muzzle pointed in the direction of any person.
- **10.** Approved eye and hearing protection is required for every person on all firearm ranges.
- **11**. No tracer rounds of any kind are to be used on the range.
- **12.** No exploding targets, exploding bullets, or incendiary devices are to be used at any time.
- 13. No glass, plastics, metals or woods not specifically and commercially designed as targets shall be used as targets on any range (vegetables, fruit, furniture, electronics, cans of any type are <u>not</u> range authorized targets). Paper, cardboard or clay targets and backers, along with proper stands shall be used at all times. No throwing devices are allowed on this range.
- After using a range you and your party are responsible for the immediate cleanup of that range. Remove used targets, pickup empty cartridge brass and live ammunition, sweep if necessary. <u>DO NOT THROW LIVE</u>

AMMUNITION INTO ANY GARBAGE CAN OR GARBAGE PILE.

- **15.** There will be no loaded firearms behind the yellow safety line
- **16.** Unwanted live ammunition can be deposited in the red "dud" can located at the rifle range.
- **17.** No armor piercing rounds fired at steel targets.
- **18.** No firing at steel targets at less than 10 yards with pistols unless using frangible ammunition.
- **19.** It is not recommended to use steel target stands less than 10 yards due to the fact you can deflect the bullet back toward you.
- **20.** No pistol carbine or rifle may be used on the pistol range unless chambered in 22lr rimfire or less. This means no 223, 5.56, 300 black out or AK 47 pistol carbine. No shotguns of any kind.
- **21.** Do not shoot the range markers, supporting posts, telephone poles, or blue sky barrier in front of the bench.

RIFLE RANGE RULES

- 1. Shooting hours begin at 9:00am and end at sunset or 8:00pm, whichever is earlier, all year long, regardless of daylight hours. After daylight shooting on the range requires specific permission from the Board of Directors for a designated date and time, and for each occurrance.
- 2. Formal events of Big Timber Rifle and Pistol Club and scheduled training by law enforcement or authorized instructors will include the designation of an official Range Safety Officer and a Match/Training Director, one person may at times be designated for both roles.
- 3. Informal shooting shall not interfere with formal events and scheduled training but may be permitted at the discrtion of the Match/Training Director of the event or training.
- 4. Firearms shall be discharged only in a safe direction, so the projectile's impact occurs in a pre-designated location specificially designed to safely dissipate all of the projectile's energy.

- 5. Only firearms in safe working order which have been properly maintained shall be discharged.
- 6. When not in a shooting station, all firearms shall be carried in a case or unloaded with the cylinder/breech open and in a safe manner. This rule extends to range parking lots.
- 7. No firearm shall be loaded until the shooter is at the shooting station. Loading is considered as putting ammunition into any part of the firearm. c. No person may go forward of a firing line except during a designated 'Cold Range.'

d. During a 'Cold Range,' all firearms are to remain safely racked and there is to be absolutely no touching or handling of any firearms.

e. During a 'Cold Range' there is to be no handling of firearms for the purposes of unpacking upon arrival or packing to leave.

f. All firearms must remain unloaded, racked or packed and untouched, while any person is down range and until the 'Hot Range' designtion is called.

g. Only after the 'Hot Range' designation is called, may firearms be once again moved to the firing line for loading/firing and/or packed and unpacked for transportation.

- **9.** A firearm shall not be handled with the muzzle pointed in the direction of any person.
- **10.** Approved eye and hearing protection is required for every person on all firearm ranges.

- **11.** No firearms chambered in .50 BMG are to be discharged on the range.
- **12.** No tracer rounds of any kind are to be used on the range.
- **13**. No exploding targets, exploding bullets, or incendiary devices are to be used at any time.
- 14. No glass, plastics, metals or woods not specifically and commercially designed as targets shall be used as targets on any range (vegetables, fruit, furniture, electronics, cans of any type are not range authorized targets). Paper, cardboard or clay targets and backers, along with proper stands and throwing devices, shall be used at all times.
- **15.** After using a range you and your party are respon sible for the immediate cleanup of that range. Remove used targets, pickup empty cartridge brass and live ammunition, sweep if necessary; unwanted live ammunition can be deposited in the red "dud" can. DO NOT THROW LIVE AMMUNITION INTO ANY GARBAGE CAN OR GARBAGE PILE.
- **16.** There will be no loaded firearms behind the yellow safety line (yellow hanging boards).
- **17.** No armour piercing rounds fired at steel targets.
- **18.** No firing at steel targets at less than 100 yards with rifles
- Weapons that are capable of being fired 'full-auto' or weapons containing other 'select fire' based trigger systems (such as 2-round or 3-round burst trigger options) are prohibited from being used on the range.
